HERE IN AFTER REFERRED TO AS THE "APPROVED CONTRACTOR" OR "PLATINUM LEVEL CONTRACTOR"

APPROVED CONTRACTOR & PLATINUM LEVEL CONTRACTORS

WHEREAS, the Supplier sells roofing products and a certain roofing system (the "System") for use on roofing projects, and the Approved Contractor and Platinum Level Contractor intend to purchase such roofing products for use in roofing projects; and

WHEREAS, the Supplier warrants its product to be free of defects and offers the American WeatherStar Material Warranty ("AWS Materials Warranty") which is offered through an application process in either five (5) ten (10) twelve (12) or fifteen (15) year increments; and

WHEREAS, the Approved Contractor and Platinum Level Contractor have the option of applying for the AWS Materials Warranty under the terms and conditions set forth herein.

TERMS

- 1) **Best Efforts:** The Approved Contractor or Platinum Level Contractor agrees to utilize its best efforts to execute said System and to deliver it to the Building Owner upon the proper completion of the project and the satisfaction of all conditions as expressed in the System. The Approved Contractor and Platinum Level Contractor agree to have special skills, knowledge, and training in the application of the System. The Approved Contractor and Platinum Level Contractor further agrees to apply the System in accordance with Supplier's written instructions and specifications and further agrees that any application of the System not in accord with such instruction will be promptly brought into accord by the Approved Contractor and Platinum Level Contractor, at the Approved Contractor or and Platinum Level Contractor's expense.
- 2) **Standard Product Warranty:** The Supplier always warrants products to be free of defects so long as the products are stored and shipped in accordance with Supplier's label directions and printed instructions. Liability shall be limited to prompt replacement of material proven defective, according to Supplier's standard terms and conditions of sale.
- 3) **AWS Materials Warranty:** The Approved Contractor and Platinum Level Contractor shall have the option of applying for the AWS Materials Warranty by completing the AWS Materials Warranty application and obtaining approval of the AWS Materials Warranty by the Supplier.
- 4) **AWS Supplier's Instructions:** The Supplier shall provide appropriate instructions (Application Guidelines) to the Approved Contractor for applying the product to appropriate and approved substrates. These instructions shall be in printed or electronic form. Should the Approved Contractor or Platinum Level Contractor fail to comply with said instructions, then the Approved Contractor or Platinum Level Contractor shall be liable and accountable for the cost of any necessary repair according to the terms of the applicable Warranty so as to put it in compliance with said instructions and specifications. The Approved Contractor and Platinum Level Contractor agrees that it fully understands the instructions and specifications for the storage and application of the product, and that it will fully comply with said instructions and specifications.

PLATINUM LEVEL CONTRACTOR

WHEREAS, the Supplier produces a certain roofing system hereinafter referred to as the "System", the properties, specification, and application instructions for which are set forth in Application Guidelines (as defined hereinafter); and

WHEREAS, in expressing their confidence in the System, the Supplier and the Platinum Level Contractor may join in making the American WeatherStar Labor and Materials Warranty ("AWS Labor & Materials Warranty") to the owner of the building ("Building Owner") to which the System is installed. Labor & Material Warranties are offered through an application process in either five (5), ten (10), twelve (12), or fifteen (15) year increments; and

WHEREAS, if the AWS Labor & Materials Warranty is issued, the Supplier and the Platinum Level Contractor will become jointly and severally liable to the Building Owner under the terms of the System and this Agreement which is executed to make explicit their rights, duties, and responsibilities to one another with respect to the System and the roofing projects to be completed; and

WHEREAS, the Supplier and the Platinum Level Contractor enter into this Agreement in reliance upon the cooperation, efforts, and expertise of the other.

TERMS

- 1) **Insurance and Indemnity:** The Platinum Level Contractor will obtain all necessary worker's compensation, liability and transportation insurance at its own expense. Platinum Level Contractor further agrees to purchase and maintain in full force and effect the insurance required to complete each project and cause Supplier to be added as a named insured therein so as to cause Supplier to be saved harmless from all claims, losses, and liabilities arising out of damage to property or injury or death of persons occasioned by or connected with the Platinum Level Contractor's operation including, without limitation, acts or omissions of the Platinum Level Contractor, the Platinum Level Contractor's approved agents, sub-contractor, employees or invitees, or the use of by motor vehicle or other equipment or property in connection therewith and from and against all claims, losses, and liabilities for costs and legal expenses.
- 2) **Pre-Project Inspection Reports:** For projects on which the AWS Labor & Materials Warranty is to be issued, the Platinum Level Contractor and/or an independent roofing consultant, to be approved by the Supplier, may inspect the roof prior to the application of any of the Supplier's products. Recommendations will be made as to how to proceed regarding substrate conditions, surface preparation, specifications, etc.
- 3) **Post-Project Inspection Reports:** For projects on which the AWS Labor & Materials Warranty is to be issued, when the job is completed, an independent roofing consultant or a representative of Supplier may meet with the Platinum Level Contractor at the job-site, and they will conduct a full inspection. Any independent roofing consultant will have all the qualifications necessary and full authority to conduct completed project inspection. If there are any voids, pinholes, fish-mouth, cracks, inadequate application of coating, and/or any other deficiencies, the Platinum Level Contractor must correct these deficiencies and a second inspection must take place. If there are no deficiencies, the Completed Project Inspection Report form (to be provided by the Supplier) will be signed by the independent roofing consultant (if applicable) and the Platinum Level Contractor and submitted to the Supplier for final approval.
- 4) **Additional Conditions:** The Platinum Level Contractor agrees as specific conditions for issuance of an AWS Labor & Materials Warranty to the following:
 - 5) The Platinum Level Contractor, solely at its expense, agrees to provide entire remedy as provided for in the AWS Labor & Materials Warranty to repair deficiencies in the roof system for a period defined in the warranty application. Deficiencies in the installed roof System include, but are not limited to, roof leaks and/or delaminating material resulting from faulty workmanship. The Platinum Level Contractor, solely at its expense, agrees to provide all labor and non-American WeatherStar materials necessary to remedy deficiencies in the installed roof System, as provided for in the AWS Labor & Materials Warranty. Supplier agrees at its expense to provide American WeatherStar materials to effectuate these repairs.

Supplier agrees to provide all materials and labor, and the Platinum Level Contractor agrees to perform repairs which may become necessary under the AWS Labor & Materials Warranty for water leaks occurring after the Platinum Level Contractor's commitment has expired through the end of the AWS Labor & Materials Warranty. Supplier reserves the right to inspect or to have an approved roof consultant inspect the roof and to issue a punch list to the contractor to be completed before Supplier releases the contractor from its labor obligations. The Platinum Level Contractor agrees not to charge for any profit on repairs performed under this agreement. It is further agreed that the Supplier must be provided notice of a potential claim as soon as received by the Platinum Level Contractor, and the Supplier agrees to provide notice to the Platinum Level Contractor of a potential claim as soon as received. It is further agreed that the Platinum Level Contractor must afford the Supplier the right to provide the materials in suitable quantities to perform the repairs. The Platinum Level Contractor agrees to provide the Supplier with a written summary of the repairs performed, separated in accordance the following:

- a) Materials (Non-American WeatherStar)
- b) American WeatherStar materials
- c) Labor Costs

PROVISIONS APPLICABLE TO BOTH LEVELS OF CONTRACTOR

- 1) **Contractor Not an Agent:** Neither the Approved Contractor nor the Platinum Level Contractor shall be construed as an agent for the Supplier. The Supplier shall not be obliged under any contracts or statements made to third parties by the Approved Contractor or Platinum Level Contractor. No third party shall be deemed an agent of Supplier for purposes of notice of claim in the applicable warranty, inclusive of payment of the applicable warranty premium.
- 2) **Breach of Contract:** If either party fails to perform any of these terms and conditions, then such nonperformance shall be treated as a material breach of this Agreement, and the non-defaulting party shall be allowed all appropriate remedies as well as contract damages.
- 3) **Venue:** In the event that an action at law is brought by either party to enforce any of the terms of this Agreement, it is agreed that any such litigation shall be commenced in Mobile County, State of Alabama.
- 4) **Authority:** The parties hereto represent and covenant that they shall cause this Agreement to be signed pursuant to the authority granted by the governing body or authorized official of the respective entity so as to empower the individual signing on behalf of the entity to so act.
